A RESOLUTION PROVIDING FOR THE RE-APPOINTMENT OF MIAJEUNENE JOHNSON AS DIRECTOR OF THE DEPARTMENT OF HUMAN RESOURCE AND CLERK OF MAYOR'S COURT, AND DECLARING AN EMERGENCY.

WHEREAS: The positions of Director of the Department of Human Resource and Clerk of Mayor's Court are appointive positions; and

WHEREAS: The Mayor has re-appointed Miajeunene Johnson as Director of the Department of Human Resource and seeks to appoint her to the Clerk of Mayor's Court; and

WHEREAS: Council confirms the various appointments made by the Mayor; and

WHEREAS: Council desires to confirm this re-appointment; and

WHEREAS: It is necessary to keep an accurate record of these various appointments as to individuals appointed and their term of office.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF HIGHLAND HILLS, OHIO:

Section 1: That Council hereby confirms the re-appointment of Miajeunene Johnson as Director of the Department of Human Resource and confirms her appointment as Clerk of Mayor's Court for the Village of Highland Hills.

Section 2: That pursuant to Village Charter, the term of said appointments shall run concurrent with the remainder of the Mayor's term of Office, or until such time as a successor has been appointed and confirmed.

Section 3: That the annual salary of said appointed official shall be as set forth in the Village Salary and Complement as determined by the Mayor.

Section 4: That this Resolution shall supersede all previously adopted legislation in direct conflict herewith.

Section 5: Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an orderly meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were conducted in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
