The Regular Council Meeting of the Village of Highland Hills, Ohio was called to order at 6:00 p.m. by Council President Cassandra Pride in Room No. 14 of Village Hall. It was also broadcast via Zoom Video Communications.

Moved by Councilman Mills and seconded by Councilman Wright to waive the three reading rule and referral to committee. All voted age and the **motion** carried.

Moved by Councilman Mills and seconded by Councilman Wright to approve Ordinance No. 2024-37. All voted age and the ordinance was **adopted 5** – 0.

Resolution No. 2024-38: A Resolution Providing for the Appointment of William D. Simpson as Director of the Department of Human Resource/Clerk of Mayor's Court, and Declaring an Emergency.

Moved by Councilman Wright and seconded by Councilwoman Greene to waive the three reading rule and referral to committee. All voted aye and the **motion carried.**

Moved by Councilman Mills and seconded by Councilman Wright to approve Resolution No. 2024-38. All voted aye and the resolution was **adopted 5 – 0.**

Ordinance No. 2024-39: An Ordinance Authorizing All Actions Necessary to Accept the Northeast Ohio Public Energy Council (NOPEC) 2024 Energized Community Grant, and Declaring an Emergency.

Moved by Councilman Mills and seconded by Councilman McManus to waive the three reading rule and referral to committee. All voted aye and the **motion** carried. Moved by Councilman Wright and seconded by Councilman McManus to approve Ordinance No. 2024-39. All voted are and the ordinance was **adopted** 5-0.

Ordinance No. 2024-40: An Ordinance Authorizing the Mayor to Enter and Execute an Agreement with Specialized Construction, Inc. for the Patterson Parkway Road Rehabilitation Project, and Declaring an Emergency.

Moved by Councilman Wright and seconded by Councilman McManus to waive the three reading rule and referral to committee. All voted aye and the **motion carried.**

Discussion: President Pride recalled that Specialized Construction has done projects with the Village in the past. Our Engineer has worked with them on over 40 to 50 projects in the community. The company is a good choice and was the lowest bidder.

Councilwoman Greene asked whether the company would be open to doing some driveways. Mayor Booker answered the homeowner would have to contact them directly.

There being no further discussion, it was moved by Councilman Mills and seconded by Councilman Wright to approve Ordinance No. 2024-40. All voted aye and the ordinance was **adopted** 5-0.

Ordinance No. 2024-41: An Ordinance Authorizing an Amendment to the Contract with Apex Construction Company for the Shaker House Elevator Replacement Project, and Declaring an Emergency.

Moved by Councilman Mills and seconded by Councilman McManus to waive the three reading rule and referral to committee. All voted aye and the **motion** carried.

Discussion: President Pride noted the amount has changed. Mayor Booker advised the change order is because the Village will have to get a monitoring company to monitor for the first year, per State code. It is only for one year.

Mayor Booker recommended President Pride bring it to the attention of the Senior Advisory Board at their next meeting.
