**A RESOLUTION EXPRESSING THE FULL SUPPORT OF VILLAGE COUNCIL FOR
THE VILLAGE'S APPLICATION TO THE CUYAHOGA COUNTY PLANNING
COMMISSION FOR THE 2026 COMMUNITY PLANNING SERVICES PROGRAM
ASSISTANCE, AND DECLARING AN EMERGENCY.**

WHEREAS, the Village of Highland Hills, Ohio recently received a grant from Cuyahoga County which enabled the Village to update its Comprehensive Plan; and

WHEREAS, the Village of Highland Hills Comprehensive Plan Update has been completed in 2025 with assistance provided from the County Planning Commission; and

WHEREAS, the Village of Highland Hills Comprehensive Plan Update contained several recommendations and goals, including revision of zoning regulations to enable implementation of land use changes recommended within the plan; and,

WHEREAS, Cuyahoga County Planning Commission currently offers planning services assistance through the 2026 Community Planning Services Program; and,

WHEREAS, This Council wishes to fully support the update of the Village Zoning and Development regulations in support of implementation of Comprehensive Plan recommendations.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF
HIGHLAND HILLS, OHIO:**

Section 1: This Council of the Village of Highland Hills finds and determines that it is in the best interest of the Village of Highland Hills to support, pursue, apply for and accept assistance from the Cuyahoga County Planning Commission related to the update and revision of Village Zoning and Development Regulations.

Section 2: Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an orderly meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were conducted in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution is declared to be an emergency measure necessary to provide for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Highland Hills, and for the reason it is necessary to immediately move forward with this resolution of support due to the time constraints for making application which expire May 20, 2026, and provided it receives the affirmative vote of two-third (2/3) of all members elected to Council, it shall take effect and be in force from and after the earliest period allowed by law.
